judicial functions

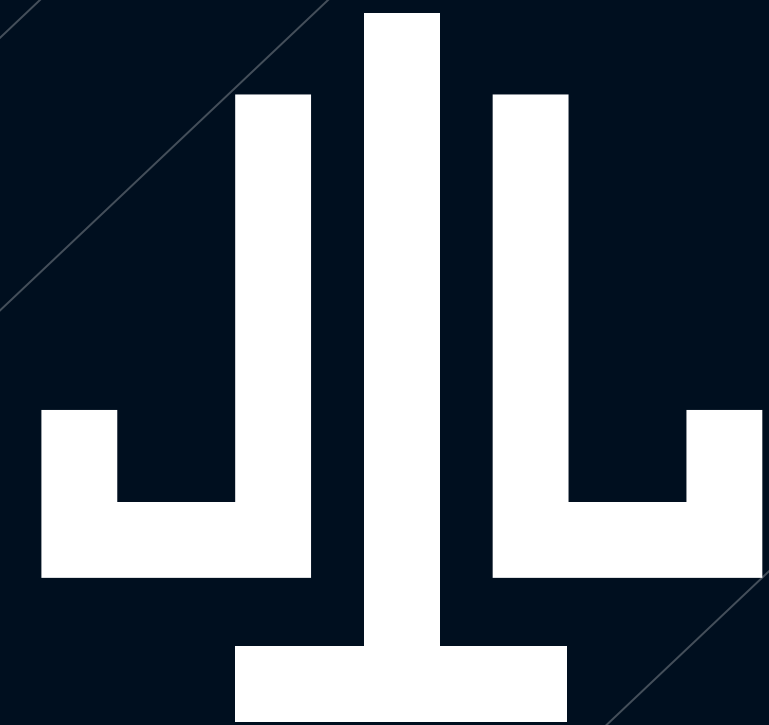
